Credicorp product comparison: Platform Payout Timing product-routing guide

A sourced product-routing guide for comparing Credicorp Loan, Credicorp Flex and Credicorp Slice when platform payout timing affects cash flow.

Platforms can show sales before cash is released, especially where reserves or disputes apply. The first check is whether the cost is dated, evidenced and likely to clear from a known receipt.

Use the product comparison route when the company is still choosing between a fixed loan, a revolving facility and splitting one invoice. That means fixing the amount before comparing rates, fees or monthly comfort.

Draw against settled or strongly evidenced cash, not a dashboard total. The links below are the source checks used for this page.

For the product comparison route, decide what shape the pressure has first: one dated gap, repeated draw-and-repay pressure, or one invoice to split.
