Credicorp product comparison: Privacy Notices director note

A sourced director note for comparing Credicorp Loan, Credicorp Flex and Credicorp Slice when privacy notices affects cash flow.

Privacy notices and data handling sit inside the operating record, especially when customer or employee data is used. Treat the borrowing as a job to be done, not as extra revenue.

Use the product comparison route when the company is still choosing between a fixed loan, a revolving facility and splitting one invoice. Compare the pounds repaid against the cost of waiting, delaying the supplier or missing the trade.

Do not treat privacy work as optional marketing copy. It supports trust, compliance and lender confidence. The citations make the route auditable without copying source text.

For the product comparison route, decide what shape the pressure has first: one dated gap, repeated draw-and-repay pressure, or one invoice to split.
